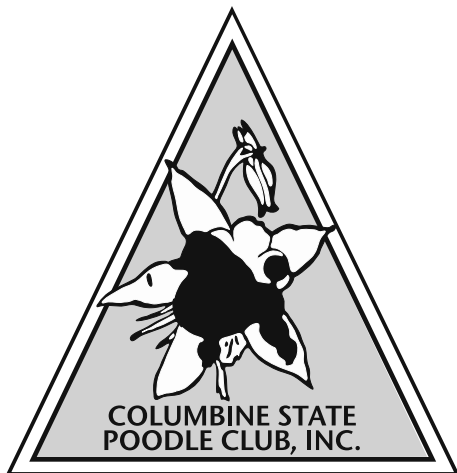

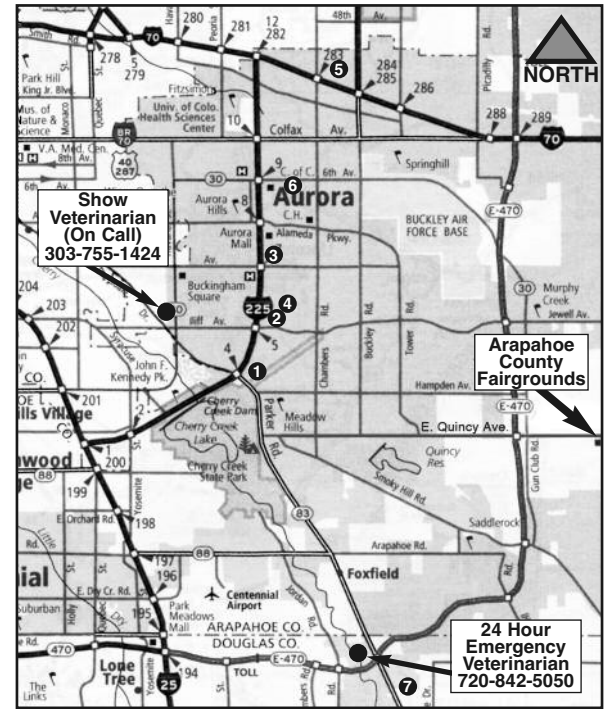

**ROUTES TO ARAPAHOE COUNTY FAIRGROUNDS**

**FROM THE NORTH:**  
 From Interstate 70, take E470 south to the Quincy Ave. exit. Turn left and go two miles to the Arapahoe County Fairground entrance on your right. E470 is a toll road.

**FROM THE SOUTH:**  
 From Interstate 25 or Parker Road, take E470 northeast to Quincy Ave exit. Turn right and go 2 miles to the Arapahoe County Fairground entrance on your right. E470 is a toll road

**ALTERNATE  
 NON-TOLL ROAD ACCESS:**  
 Take Parker Road to Quincy Ave. Go east 5 miles, across E470, to the Arapahoe County Fairgrounds entrance on your right.
